Sealed quotations are invited for Annual Contract for Photocopying works at NCW.

The Terms and conditions of contact are as under:-

- i) The agency will be required to install a photocopier along with an efficient resident Photocopy Operator from 9.00 a.m. to 6.00 p.m. on all working days i.e. from Monday to Saturday. The agency shall also provide Xerox paper of good quality (weight 75 GSM).
- ii) Space for keeping the Xerox Machine and Electricity for running for the machine will be provided by the Commission.
- iii) The agency will be solely responsible for proper upkeep and maintenance of Xerox machine. Faults, if any shall be rectified by the agency it self. Before attending to any fault, the operator deputed by the agency will take all safety precautions. The Commission will not be responsible for any injury, loss and misshaping, if any, occurs to the Operator during the course of operation and maintenance of the Xerox machine.
- iv) The payment will be made on monthly basis, in case operator fails to attend office on any of the working days the work pf photocopy done from market the difference of expense will be reduced from his bill.
- v) If interested, kindly quote your rates per month for providing the above said services. The other charges viz, service tax etc. if any, should be clearly indicated in the quotation (i.e. whether rates quoted by you is inclusive of Taxes).
- vi) In case the Photocopy work is not done in time or the same has not been done to the satisfaction of the Commission, the contract may be terminated.
- vii) The rate quoted should remain valid for one year from the date of award work.
