

National Commission for Women invites quotation for disposal of 2 (Two) Ambassador (1800 & 1817 cc) cars (2011 Model). The cars are not in running condition and will be disposed off on "as is where is basis".

2. The parties interested to purchase the vehicle may send their quotation in the proforma at Annexure II along with earnest money of Rs. 10,000/- (Rupees ten thousand only) (Rs. 5,000/- for each car) in the form of Demand Draft drawn in favour of PAO, National Commission for Women, payable at New Delhi in a sealed cover super-scribed as "Quotation for disposal of staff car". The quotation may be send by registered post or by speed post to the Under Secretary (GA), National Commission for Women, Plot No. 21, Jasola Institutional Area, New Delhi-110025 alongwith EMD and other requisite documents so as to reach on or before 22nd April, 2024 by 3.00 PM. The quotations can also be handed over personally at the Receipt Section of the National Commission for Women, at Plot No. 21, Jasola Institutional Area, New Delhi 110025. The bids shall be opened on the same day at 4.00 PM. The tenderers who wish to be present at the time of opening may do so. The terms and conditions of the tender are given in Annexure I.

TERMS AND CONDITIONS FOR DISPOSAL OF VEHICLE OF NATIONAL COMMISSION FOR WOMEN (NCW)

The terms and conditions for the disposal of the vehicles are as follows:

1. An EMD of Rs. 10,000/- (Rupees ten thousand only) (Rupees 5,000/- for each vehicles) for two vehicles in the form of Demand Draft/Bankers cheque etc. in favour of PAO, National Commission for Women , payable at New Delhi should accompany the bid. The bids without EMD will be summarily rejected.
2. The successful bidder has to deposit the entire bid money within two working days after the acceptance of the bid. The EMD of Rs. 10,000/- (Rupees 5,000/- for each vehicle) will be forfeited in case the bidder backs out for whatever reasons. The EMD of unsuccessful bidder will be returned only after the vehicle is removed from the premises of NCW by the successful bidder.
3. Bidders may visit National Commission for Women for inspection of vehicle on any working day from 10 AM to 5 PM on or before 19th April, 2024.
4. The vehicle will be disposed of on **"As is where is basis"** and no guarantee to its roadworthiness or quality etc. is given by the National Commission for Women.
5. Quotations received after due date/time and without earnest money/requisite documents will not be entertained.
6. The bids with overwriting/cutting in the quoted rates will not be considered.
7. The disposal will ordinarily be in favour of the highest evaluated bidder, whose bid has been found to be responsive and who is eligible and qualified as per terms and conditions of the tender.
8. The successful bidder has to remove the vehicle from the premises of National Commission for Women at their own expense within 2 working days of acceptance of the quotation of the successful bidder and after making the required payment. The bid amount by the successful bidder will be deposited by Demand Draft, Bankers cheque etc. in favour of Pay & Accounts officer, National Commission for Women, payable at Delhi.
9. The bidders will not be allowed to withdraw their bids failing which their earnest money will be forfeited.



10. The successful bidder has to submit self-attested copy of (1) Aadhar Card/Voter I D Card and (2) Pan Card and (3) two recent passport size photographs. The Commission reserves the right to verify the antecedents/documentary proof of his address.
11. In case the highest quoting bidder fails to honor the bid, the next opportunity will be given to the next highest eligible bidder(H2).
12. The successful tenderer will be responsible for getting the registration certificate of the vehicle in his name expeditiously. The National Commission for Women will not be responsible for any lapse on the successful tenderer's part in this regard.
13. The successful bidder who takes possession would be responsible for the bonafide/lawful use of the vehicle.
14. Employees of National Commission for Women are not eligible to participate in this bid.
15. The National Commission for Women reserves the right to accept or reject any/all the quotation without assigning any reason.
16. The bids should remain valid for 30 days.
